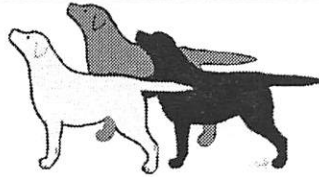

10 GOOD REASONS TO PLACE A LABRADOR RETRIEVER WITH LABRADOR RETRIEVER RESCUE, INC.

1. We have home studied all of our potential Lab Rescue adopters. After we receive an acceptable adoption application, an experienced Lab rescue volunteer visits the home. We have checked the adopters home, fencing, and family to make sure they have a realistic idea on Lab ownership and the time needed for a Lab. With the application information and the home study report, we are able to match the Lab with a suitable family.
2. All rescue Labs are medically updated and spayed/neutered prior to adoption. LRR asks the owners to update their Labs before coming into our adoption program whenever possible.
3. LRR, Inc. offers individualized dog training if necessary.
4. The adoptive owners sign a contract with LRR, Inc. stating they must return the Lab to rescue if they cannot keep the Lab.
5. LRR, Inc. offers a neutral zone between the current owner or breeder and the new adopter.
6. Adopters sign a contract stating they will care for, feed, vet, and not allow the Lab to run loose.
7. LRR, Inc. has the right to have the Lab returned if the home is found to be unsuitable after the adoption.
8. Our volunteers have hands on knowledge and experience with Labs and can assist the adopters before and after adoption.
9. If requested, LRR, Inc. is willing to update the breeder or family giving up the Lab to LRR, Inc. after the adoption.
10. We are here today, tomorrow and years to come to help the adopted Labs.

Please note: LRR, Inc. volunteers always ask if the owner wishing to surrender a Lab has a contract with the breeder stating that the Lab is to be returned to the breeder. We encourage the owners to follow through and honor these contracts. Breeders can then work with LRR, Inc. to help find the Lab a new home.

Nominations for Officers and Board of Directors

It is of that time when we begin looking for volunteers to help in the management of the club and our activities. If you can volunteer your time and would like to participate in our Clubs organizational structure, Please contact Joey Mead Edsall at Joey_Mead@uml.edu or Karen Kennedy at Pleasantpine@aol.com for more information.. Meetings are usually the 2nd Wednesday of each month

Article III Section 2

OFFICERS: The Club's Officers consisting of the President, Vice President, Corresponding Secretary, Recording Secretary, Treasurer, Newsletter Editor and immediate Past President shall serve in their respective capacities both with regard to the Club and its meetings and the Board and its meetings.

- a. The President shall preside at all meetings of the Club and of the Board and shall have the duties and powers normally appurtenant to the office of the President in addition to those specified by these By-Laws.
- b. The Vice President shall have the duties and exercise the powers of the President in the case of the President's death, absence, or incapacity.
- c. The Recording Secretary shall keep record of all meetings of the Club and of the Board and all other matters of which record shall be ordered by the Club.
- d. The Corresponding Secretary shall have charge of the correspondence, notify members of meetings, and notify new members of their acceptance to membership, notify officers and directors of their election to office, keep a roll of the members of the Club with their address, and carry out such other duties as are prescribed in these By-laws.
- e. The Treasurer shall collect and receive all moneys due or belonging to the Club. He shall deposit same in bank designated by the Board, in name of the Club. His books shall at all times be open to inspection by the Board and he shall report to them at every meeting the condition of the Club's finances and every item of receipt or payment not before reported; and at the Annual Meeting he shall render an account of all moneys received and expended during the previous fiscal year. The Treasurer shall be bonded in such amount as the Board of Directors shall determine.
- f. The Newsletter Editor shall be in charge of publishing the newsletter.

Article IV Section 4.

NOMINATIONS: No person may be a candidate in a Club election who has not been nominated. During the month of December, the Board shall select a Nominating Committee consisting of three members and two alternates, not more than one of whom may be a member of the Board. The Corresponding Secretary shall immediately notify the committeemen and alternates of their selection. The Board shall name a Chairman for the committee and it shall be his duty to call a Committee Meeting which shall be held prior to January 1.

- a. The Nominating Committee shall meet prior to January 1 to draw up a slate of nominations, there being one nominee for each person nominated. The Committee shall be immediately report their nominations to the Corresponding Secretary in writing.
- b. Upon receipt of the Nominating Committee's report, the Corresponding Secretary shall notify each Club member in writing by January 15th.
- c. Additional nominations may be made at the February meeting by any member in attendance provided that the person so nominated does not decline when his name is proposed and provided that if the proposed candidate is not in attendance at this meeting, his prosper must present to the Corresponding Secretary a written statement from the proposed candidate signifying his wiliness to be a candidate. No person may be a candidate for more than one position and the additional nominations which are provided for herein may be made only from among those Club members who have not accepted a nomination of the Nominating Committee.
- d. Election shall take place at the Annual Meeting in March.
