### Research Report

Genetic testing for the mutation highly associated with canine Exercise Induced Collapse (EIC) is now available. It requires a blood draw by a veterinarian and submitting the blood sample to the University of Minnesota's Veterinary Diagnostic Laboratory. The mutation has been found to be common in Labrador Retrievers, and has also been identified in Chesapeake Bay Retrievers, and Curly-Coated Retrievers. Further research is underway to see if the mutation exists in other breeds. It is a UMN Veterinary Diagnopstic Laboratory policy to submit samples through, and report results to, a veterinarian. Direct involvement of a veterinarian allows for optimal management of this genetic disease, as well as other concurrent medical conditions a dog may have that will affect its management. All needed information for submission is on the following website:

This test is reasonably priced at \$65.00 and it will identify clear dogs, carrier dogs, and affected dogs. The Orthopedic Foundation for Animals, Inc. is the official data collection site and the information for submission of test results is there. The Labrador Retriever Club, Inc was a major sponsor of this research.

### Ongoing Volunteer Opportunities

We need knowledgeable Lab people for a variety of volunteer opportunities throughout our service area. Most tasks involve a small time commitment, just a few times a year:

- Foster homes (not kennels) provide a temporary residence where the dogs can be observed in a natural, family setting, pending adoption by previously screened applicants. The typical stay in foster care is 1-2 weeks.
- Conduct home studies of people in your area who have applied to adopt from LRR. You and your Lab visit applicants, by appointment, and complete a home study form. Each visit takes 30 minutes to 1 hour.
- Evaluate Labs at shelters, vet clinics, or private homes for temperament, health, and to make sure the Lab is purebred. Each visit takes 30 minutes to 1 hour.
- Other opportunities include basic obedience training, transport, publicity, fundraising, public education.

### UC DAVIS ONLINE BIRTH DEFECT STUDY

Researchers in the Bannasch Laboratory at the School of Veterinary Medicine, University of California-Davis are initiating a long term study on canine birth defects (CBD). The birth defects currently being targeted are cleft palate, umbilical hernia (requiring surgical correction), and cryptorchidism. As part of the study the researchers are interested in determining if puppies are predisposed to birth defects when bitches are exposed to certain environmental factors. In addition, they will also determine genetic causes of these specific birth defects. In order to address these two issues, they need information about the bitches' gestational environment as well as DNA samples from affected and unaffected puppies.

They are asking breeders to use the following link to fill out an online survey about litters born in the last year. In order to fill out the survey, the breeder will need to have the litter registration information and the ability to print. If breeders are willing to send DNa samples, contact information is available at the end of the survey.

### **Delaney Group Procedures**

Mass Wildlife is charging \$25 per session for use of the Delaney Watershed area. To defray these costs, we collect the following fees:

- 1. Beginners Class: For participants in the LRCGB Beginners Class, the fee for the class covers the grounds fee for the duration of the class. Participants wishing to use the grounds after completion of the class may do so for a fee of \$20 per person for the rest of the season. The Beginners Class will have first priority for selection of grounds for the duration of the class.
- 2. Club Training: LRCGB members may pre-pay for the season for a fee of \$35 per person. After the Beginners Class ends, pre-paying participants will have first priority for selection of grounds.
- 3. Members wishing to pay for use of the grounds on a daily basis may do so for \$5 per handler, per day. Prepaying participants will have priority in running their dogs; drop-in participants will get a refund if their runs cannot be accommodated because we are running out of daylight. Drop-ins should let the group know by Monday 5pm (the day before) if they will be attending that Tuesday. ### Delaney group procedures

- When entering the roadway, please drive 5 mph. We'd like to keep a good relationship between our training group and the dog walkers.
- Participants should let the group know if they will be attending and how many dogs by Monday 5pm (the day prior) Tuesday's session.
- Be prepared to work in the field and provide equipment. The club has some equipment, but is dependent on others to provide starter pistols, etc. At a minimum, participants are expected to bring a duck call, whistle, and a working radio.
- Running order and substitution will be provided at the beginning of the session. This substitution order may include providing assistance to the Beginners Class.
- Each week will have a pre-arranged set up, which will be designed to teach dogs of different levels. Prior to the training session we will discuss the set-up, what it is designed to teach and how to run the set-up depending on the level of your dog. We will work with you to help you run the appropriate set-up for your dog.

- The training session are expected to start at 5:00 and run until dark. If you arrive late you may not be able to run all the set-ups.
- This is a training session, think about what you want you and your dog to LEARN. Do not try to win the training session, you will have ample time to demonstrate your dog's ability at the tests. While all dogs have bad days, if you dog appears to consistently have problems, then you may want to consider that the task you have asked is beyond the current ability of your dog. All dogs learn at different rates and have different problems. Do not feel your dog should be able to do the most difficult set-up or that a training approach used by one member is always the right approach for your dog. Don't hesitate to ask more experienced handlers for suggestions how to simplify if you're in doubt. Ask questions!
- Please make sure your dog is ready to run when it is your turn. Ideally, there is always a dog in the holding blind. Air your dog in advance, pick up after your dog!
- Please be aware that we're sharing the grounds with other people walking their dogs. If someone complains, be courteous, offer to explain what we are doing, but do not get into arguments.

I know we don't have time to read more email - but think about getting at least one for your home state or for dogs only. This one is much less busy than Petlaw but often has the same cross posts that it does. Send an email to: doglegislation-subscribe@yahoogroups.com to set up a subscription. If you don't like it you can always unsubscribe.

Communicating with Legislators By Mail or Fax

- · First Rule! DO NO HARM be Polite!
- Use the proper form of address on the envelope and inside address. For senators and representatives: The Honorable [Full Name]
- Start your letter: Dear Senator [last name] or Dear Representative [last name]
- Make your letter legible. Handwritten letters are great, but if your handwriting isn't very easy to read, type the letter! It must contain your name, return address and telephone number readable!
- Always be polite. Never, never preach, threaten, or scold!

In the first sentence, state your position. "I oppose [bill number]" or "I am against..."

- Then introduce yourself: "I am a hobby breeder of Flat Island Zorchers in Bug Run."
- Be clear and concise. State exactly why the legislation concerns you
- Focus on one or two issues at a time don't try to cover everything in one letter.
- Use personal examples. Say how the legislation would affect you.
- Say exactly what you want not ,"Please consider this carefully," but "Please vote AGAINST this."
- Keep it short no more than one page long. End by saying "Thank You" and "I look forward to your response."

# AKC SURVEY FINDS MAJORITY OF OWNERS WOULD DEFY EMERGENCY EVACUATION ORDERS AND STAY WITH PETS

### Despite Ominous Predictions for 2006 Hurricane Season, Poll Shows Even Responsible Pet Owners Not Prepared For an Emergency

**New York, NY** – A survey conducted by the American Kennel Club<sup>®</sup> shows that pet owners overwhelmingly consider their four-legged companions as members of the family. If forced to evacuate their homes to a location where they could not bring their pets, 62% of those polled would defy the authorities and stay with their animals.

The National Oceanic & Atmospheric Administration's National Weather Service is expecting "an above-average Atlantic hurricane season." The season officially starts June 1. This week, May 21-27, is NOAA's National Hurricane Preparedness Week.

### Majority are Responsible Pet Owners

A significant majority of those surveyed are responsible, caring pet owners.

- 97% would take their pets with them in case of an evacuation
- 97% keep up with vaccinations
- 79% permanently identify their pets through microchipping or tattoo
- 62% have a family evacuation plan in case a natural disaster hits
- 61% have a pet evacuation plan
- 23% were prompted to design an emergency plan for their pet after Hurricanes Katrina/Rita
- 91% of owners say they have a copy of their pet's vaccination records, 79% have their AKC registration papers, 93% have an extra leash and 89% have extra dog food—some of the basics for a pet disaster kit

### Despite Love for Pets, Owners Not Ready for an Emergency

While survey respondents overwhelmingly consider their animals to be members of the family, there are some troubling indicators that many are not prepared to safely evacuate their pets if the need arises.

- Of those who do not have an evacuation plan for their pet, 22% say it is because they live in a geographic location that isn't a likely target for terrorism or is not susceptible to natural disasters or other disasters, while over half (52%) said they would like to have one but didn't know how
- While a majority of owners have vaccination records and extra food and water on hand for their pets, three

"The threat of a disaster, both natural and otherwise, is always present," said AKC spokesperson Lisa Peterson. "While those owners surveyed obviously love and care greatly for their pets, it's alarming that many of them are not prepared to safely evacuate their animals at a moment's notice. With hurricane season at our doorstep and the continued threat of terrorism, we advise that all pet owners prepare well in advance for all kinds of emergency situations and always heed the advice of authorities."

"We are expecting an above-average hurricane season," said Dennis Feltgen, Meteorologist and Public Affairs Officer for the National Oceanic & Atmospheric Administration's National Weather Service. "Prepare, prepare, prepare. We know that people who have a hurricane plan, and execute that plan, fare much better than those that do not. Many people consider their pets as members of the family, and we saw evidence of this in the Gulf region during Katrina. Some shelters may take pets, but many will not. Make sure your pet is part of your storm plan."

 A higher percentage of those polled nationwide have an evacuation plan for their pets (61%) than the number of pet owners in the Midwest who have evacuation plans for themselves and their families (58%)

### Pet Owners Level of Preparedness Varies by Region

### Southwest

14% of Southwest residents do not have their pets vaccination records in their home, the lowest percentage compared with other regions

### **Northwest**

- 30% of Northwest residents who say they did not have an evacuation plan claim that it is because they live in a geographical location that isn't a likely target for terrorism and is not susceptible to natural disasters. This is 8% higher than the national average
- 74% of those Northwest residents surveyed microchip their pets, which is significantly higher than the national average (65%)
- 99% of those surveyed in the Northwest are up to date with their pets' vaccinations, the highest in the U.S.

### **Southeast (including Gulf States)**

- The impact of hurricanes Katrina and Rita were apparent in the survey findings, as Southeast residents are the most prepared to safely evacuate their pets in case of an emergency, with nearly three quarters of those polled (74%) reporting that they have an evacuation plan for their pet and 29% reporting they have a pet disaster kit assembled
- Over a quarter (28%) of Southeast residents designed a pet evacuation plan because of Hurricanes Katrina and Rita.

### **Northeast**

- Not surprisingly, the Northeast lead the nation in the number of respondents who created an evacuation plan for their pet after September 11 (16% of Northeast respondents vs. 8% nationally)
- However, the Northeast was the lowest in the nation to have an evacuation plan for their pet (51%)

### **Midwest**

 In the Midwest, 82% of pet owners claim they do not have a pet disaster kit assembled in case of an evacuation, the highest percentage in the nation

### **AKC Announces New Program for Mixed Breeds**

**New York, NY** – For the past 125 years, the American Kennel Club® has been the nation's premier advocate for dogs and the people who love them. The AKC's Board of Directors has voted unanimously to proceed with a program for mixed breed dogs which will allow it to act even more broadly and effectively as the dog's champion. "Our goal in creating a program specifically designed for mixed breeds is to share our passion for dogs and our sport," said AKC President and CEO Dennis Sprung. Then beginning April 1, 2010 enrolled dogs will be eligible to compete in mixed breed classes at standalone AKC Agility, Obedience and Rally events. Soon after they will have access to benefits such as discounted AKC Companion Animal Recovery Lost and Found service, a free AKC Canine Good Citizen® certificate for dogs passing the CGC test, a free initial veterinary visit, a trial offer of pet health insurance and discounted coupons for dog supplies.

The third phase will offer a dedicated Web site where dog owners can interact via an online community with discussion forums and access dog care video downloads, advice from experts and the most up-to-date news on canine health and welfare. The site will be continually enhanced with new features and benefits in order to respond to the changing needs of pet owners.

This new AKC initiative is the first designed to specifically benefit mixed breed dogs and their dog owners, however the AKC has long included mixed breeds in programs such as AKC Canine Good Citizen®, AKC S.T.A.R. Puppysm, AKC Responsible Dog Ownership Day and the AKC CAR Canine Support and Relief Fund's disaster relief efforts. In addition, AKC has always actively advocated for the rights of all dog owners and the welfare of dogs through its Government Relations efforts and serves dog owners through its affiliate organizations such as the AKC Humane Fund, AKC Canine Health Foundation and AKC Companion Animal Recovery.
