When Barbara first came to the assisted living she was so sad, she had to give up her dog to come there. Every sobbing visit took a bit of a toll on Hawke, and it would usually be our last visit of the day. Hawke would walk a little slower, drag her back feet when we were done, and it was time to go home. I know Hawke brought her much peace, just to have that dog to hold, and hug, and laugh or cry with.

Hawke has lost a few folks over the years. Al, a nice man, very quiet, who never left his room. His wife was gone, his life was just empty, but he so loved Hawke. "She's a looker", he'd always say. He'd give her great pats, and after a few months, we'd find him in the lobby, awaiting her visits. Little by little, he accepted life at the assisted living, going on trips, participating. But never on a Hawke day, he'e always be there waiting... "She's a looker", "What a great companion, and look at how she looks at you... now that is devotion" Al never missed a Hawke visit. And Hawke's friend Betty, who always said, "Hawke give the best kisses, I don't have a man to kiss me now, but Hawke gives the best kisses".

Tommorrow, Hawke will be 9. She has changed my life for the better. Without her, I would not have all my dog friends, all the fun we have at agility, rally and obedience trials and classes. Without her, and her siblings, we would have been cold indeed in the Ice Storm of '08, how does anyone sleep without a labrador? Without Hawke, I never would have gone back to school to be a Vet Tech, or taken a second round of "back to school" to work on my Masters' in Education. Like Roger Caras said, "Dogs don't make our

whole lives, they make our lives whole." I have met so many people, out of my usual paths; the folks at the assisted living, the folks at the Alzheimer's unit, the dozens of kids who read to Hawke, the many scouts who have met my dogs in badge presentations, the folks I've met in all the internet groups, talking about positive training, field training, orthodogs, Labsr4U, Labrador Life Line, Labrescue, Front and Finish and more....

A huge chunk of my world wouldn't exist without Hawke, Kestrel and Merlin. How big a chunk of your world have your Labs brought to you? Today, take a moment and think about how your Labs enrich your life. Think beyond the titles, the training, the endless poop picking, and look at how they have enriched your life, the people you've met, the places you've gone, the things you have seen through a dog's eyes.

Dear Lab Breeders:

I want to express my most sincere thanks to the Labrador Retriever breeding community for your business & support of Pawsitive I.D. over the last 2 years and particularly since our re-launch in December. Lab breeders have been one of our primary customers since day 1 and I want

you to know that our business has been built around the loyalty, confidence & patience you and your fellow breeders have shown us. Our number 1 goal is to provide breeders with a revolutionary genetic testing resource like no other. And although we do experience some growing pains from time to time, we feel as though we are meeting our goals. If you think otherwise, please let us know. Critical feedback is paramount in fixing any problem and we welcome it.

My reason for this email is to address critical feedback we have either received directly or have seen posted on some of your numerous blogs concerning our turn around time. This is really the only complaint we get. And rightly so. You as a customer and a breeder need timely results on the genetic tests you purchase from us. Although we had met our goal of 30 days or less on almost 100% of the purchased tests since December 2008, we are currently experiencing an equipment problem in The Bahamas that has delayed the processing of the PRCD portion for 47 customers, some of which are Lab breeders. We hope to have these tests finished and uploaded into our Customer Portals by the middle of this week. These 47 customers will have had a 30-40 day window due to these technical problems.

A 30-40 day turn around time is unacceptable and we realize this. However, when our system has worked properly, we have had turn around times of 21 days or less. In fact 22% of tests have been processed in this time frame since December. We are investing a great amount of funds in the Freeport lab to help expedite our results and we believe we will be able to improve our time to 21 days or less within the next 60 days, hopefully sooner.

InGen and Pawsitive I.D. have many exciting plans for the future including several new popular disease screenings and physical attribute tests in addition to a more timely turn around time. All of this is made possible by you and your business & support.

Please feel free to contact me directly at anytime with any question or concern you may have regarding our product or any other issue as it relates to your breed and genetic testing. I am always at your service.

Our Labs come from, and are placed in, homes in Massachusetts, New Hampshire, Vermont, Rhode Island, and Maine.

We need knowledgeable Lab people for a variety of volunteer opportunities throughout our service area. Most tasks involve a small time commitment, just a few times a year:

- Foster homes (not kennels) provide a temporary residence where the dogs can be observed in a natural, family setting, pending adoption by previously screened applicants. The typical stay in foster care is 1-2 weeks.
- Conduct home studies of people in your area who have applied to adopt from LRR. You and your Lab visit applicants, by appointment, and complete a home study form. Each visit takes 30 minutes to 1 hour.
- Evaluate Labs at shelters, vet clinics, or private homes for temperament, health, and to make sure the Lab is purebred. Each visit takes 30 minutes to 1 hour.
- Other opportunities include basic obedience training, transport, publicity, fundraising, public education.

PROVIDENCE — The Rhode Island Rabies Control Board has approved a change in policy that could pave the way for regulations that will allow the vaccination of dogs and cats every three years, rather than every two years.

The board approved a proposal to work with lawyers on regulatory language that would allow vaccines to be administered in accordance with the "durations of immunity" listed on the manufacturers' label, said the state's veterinarian, Dr. Scott Marshall.

Delaney Group Procedures

Mass Wildlife is charging \$25 per session for use of the Delaney Watershed area. To defray these costs, we collect the following fees:

1. Beginners Class: For participants in the LRCGB Beginners Class, the fee for the class covers the grounds fee for the duration of the class. Participants wishing to use the grounds after completion of the class may do so for a fee of \$20 per person for the rest of the season. The Beginners Class will have first priority for selection of grounds for the duration of the class.

2. Club Training: LRCGB members may pre-pay for the season for a fee of \$35 per person. After the Beginners Class ends, pre-paying participants will have first priority for selection of grounds.

3. Members wishing to pay for use of the grounds on a daily basis may do so for \$5 per handler, per day. Prepaying participants will have priority in running their dogs; drop-in participants will get a refund if their runs cannot be accommodated because we are running out of daylight. Drop-ins should let the group know by Monday 5pm (the day before) if they will be attending that Tuesday. Delaney group procedures

• When entering the roadway, please drive 5 mph. We'd like to keep a good relationship between our training group and the dog walkers.

• Participants should let the group know if they will be attending and how many dogs by Monday 5pm (the day prior) Tuesday's session.

• Be prepared to work in the field and provide equipment. The club has some equipment, but is dependent on others to provide starter pistols, etc. At a minimum, participants are expected to bring a duck call, whistle, and a working radio.

• Running order and substitution will be provided at the beginning of the session. This substitution order may include providing assistance to the Beginners Class.

• Each week will have a pre-arranged set up, which will be designed to teach dogs of different levels. Prior to the training session we will discuss the set-up, what it is designed to teach and how to run the set-up depending on the level of your dog. We will work with you to help you run the appropriate set-up for your dog.

• The training session are expected to start at 5:00 and run until dark. If you arrive late you may not be able to run all the set-ups.

• This is a training session, think about what you want you and your dog to LEARN. Do not try to win the training session, you will have ample time to demonstrate your dog's ability at the tests. While all dogs have bad days, if you dog appears to consistently have problems, then you may want to consider that the task you have asked is beyond the current ability of your dog. All dogs learn at different rates and have different problems. Do not feel your dog should be able to do the most difficult set-up or that a training approach used by one member is always the right approach for your dog. Don't hesitate to ask more experienced handlers for suggestions how to simplify if you're in doubt. Ask questions!

• Please make sure your dog is ready to run when it is your turn. Ideally, there is always a dog in the holding blind. Air your dog in advance, pick up after your dog!

• Please be aware that we're sharing the grounds with other people walking their dogs. If someone complains, be courteous, offer to explain what we are doing, but do not get into arguments.

Communicating with Legislators By Mail or Fax

• First Rule! DO NO HARM - be Polite!

• Use the proper form of address on the envelope and inside address. For senators and representatives: The Honorable [Full Name]

• Start your letter: Dear Senator [last name] or Dear Representative [last name]

• Make your letter legible. Handwritten letters are great, but if your handwriting isn't very easy to read, type the letter! It must contain your name, return address and telephone number – readable!

Always be polite. Never, never preach, threaten, or scold!

In the first sentence, state your position. "I oppose [bill number]" or "I am against..."

• Then introduce yourself: "I am a hobby breeder of Flat Island Zorchers in Bug Run."

• Be clear and concise. State exactly why the legislation concerns you

• Focus on one or two issues at a time – don't try to cover everything in one letter.

• Use personal examples. Say how the legislation would affect you.

• Say exactly what you want – not ,"Please consider this carefully," but "Please vote AGAINST this."

• Keep it short – no more than one page long. End by saying "Thank You" and "I look forward to your response."

Two Ways to Protect Your Rights:

AKC PAC | AKC Canine Legislative Support Fund

• The AKC Government Relations team is working hard to protect the rights of dog owners, breeders, and fanciers throughout the country, but we need your help!

Why are there two funds, and what's the difference?

The Canine Legislative Support Fund is used to educate and lobby elected officials on your behalf at the federal, state, and local levels and to ensure your rights as a responsible dog owner are protected. These funds may not be used to contribute to political campaigns. AKC Political Action Committee (PAC) funds are used to contribute to campaigns to help elect dog-friendly leadership in congress and state houses across the nation. PAC funds may not be used to lobby officials once they are in office or to influence legislation. They may only be used in campaigns.

AKC PAC: Help Support Dog-Friendly Government Officials

One of the most important ways to protect your rights is by ensuring that there are dog-friendly elected officials in the state and federal governments. To accomplish this, the AKC has established the AKC Political Action Committee (AKC PAC), where one-hundred percent of the funds go directly to help elect dog-friendly candidates. Contributions may not be earmarked for individual candidates, but donors may make recommendations to the PAC Board about candidates they believe are worthy of support.

Who can contribute to the AKC PAC?

Any member of an AKC-affiliated club may contribute. AKC-affiliated clubs may hold fund-raisers for the PAC and may solicit or provide opportunities for their members to make PAC contributions. Labrador Retriever Tricuspid Valve Disease

Researchers at the University of Pennsylvania are conducting a study on Tricuspid Valve Dysplasia (TVD) in Labrador Retrievers. TVD is a congenital cardiac defect, is heritable, and can lead to heart failure. The research team is seeking to identify the responsible gene(s), and are in need of blood samples from affected dogs as well as their immediate relatives (affected or unaffected).
