A dog on a scale, and our ability to breed and own dogs hangs in the balance, and an empty collar hooked to a leash, the point was that some "animal" organizations are actually against our right to own and breed dogs.

We are heading into New England's 5th favorite sport, after baseball, basketball, hockey and football POLITICS. We are looking at primaries and elections. Make sure those candidates you consider, consider your views on dog related issues. Our Legislative liaison Stephanie Davis sends emails to all active members with news of upcoming legislation, but take a more proactive stance. If you are in Mass, consider MassFed http://www.massfeddogs.org/, in New Hampshire, consider D.O.G.S, dog owners of the granite state, www. Nhdogs.org, or the Federation of Maine Dog Clubs http://www.fedmedogclubs.org/

Find out what is going on in your area, do letters need to be written, and do these organizations need your support speaking at legislative hearings? Those animal organizations who really do not favor ownership of animals have HUGE coffers, they have HUGE lobbying efforts, and their goals sound good, at first..... Dig in , find out.... Worcester, Massachusetts is tightening the rules for owning a pit bull. The Worcester City Council approved new regulations as of 9/7/2010 that will make it more expensive to license pit bulls and other dangerous dogs, and require them to be leashed or muzzled while off their property. http://www.necn.com/09/08/10/Worcester-approvesnew-pit-bull-regulati/landing.html?blockID=306872&feedID=4206

What does that mean for labs? It's not a very long road from banning pit bulls to looking at the bite records of all dogs, and Labradors being the largest number of registered dogs, could quickly come onto some town or municipality's radar as a dangerous breed. As dog owners, dog breeders, and those who compete with dogs, we



need to be vigilant. The days of Mayberry, small town life, and let a dog be a dog are gone. We need to be sure that our rights as dog owners are preserved. I for one would like to own a purebred lab for the rest of my lifetime and not be

told that I cannot have a dog from a breeder or that I cannot own a dog at all. I am sure I am preaching to the choir, but please, put your dog agenda on to the list of things you personally consider when considering a candidate...





Lab Rescue from the

Home Evaluator's Perspective

(or how Rosie and Mango Decide Who Gets a Dog)

In an ideal world, every Lab born in the world would have their own forever home, but for a variety of reasons, this sometimes can become impossible. Labrador Retriever Rescue, Inc. has a network of volunteers who evaluate Labs, foster them, train them, raise funds for them, and decide what dog goes where once the home evaluator visits an applicant and stamps the seal of approval on the potential home.

For several years I've done a variety of things to help rescue dogs and get them to new homes. I figure it's my way of paying back for having wonderful, happy healthy dogs of my own, and the means to keep them. For about 10 years I've gone to prospective homes to help decide who should have a rescued Lab in their life. My 'territory' is most of Rhode Island and some of Massachusetts.

Someone somewhere in the history of the organization thought it was a wonderful idea to take a Lab on a home visit. In my opinion as an evaluator, this is one of the more critical components of the whole evaluation experience. I used to regularly take my most mischievous and friendly girls, Rosie and Mango. Rosie began evaluating homes when she was a puppy. Mango is now 7 years old and I think her first home visit was when she was about four months old. Rosie has now moved to Virginia where she continues to do missionary work with the sick and elderly, and Mango now shares the evaluation duties with her children and grandchildren. I don't think I'll ever had as good a 'tag team' as Rosie and Mango, but time marches on and things change.

Rosie's job on the home visit was to check all the corners of the house. Upstairs and down, closets, boxes, cat food, and water... she investigated as if she was working for the FBI. Mango's job was typically to charm the occupants of the house while Rosie did her investigating. Mango diverted the attention of the people asking

for belly rubs and giving kisses, and Rosie went about her business, usually undetected until she discovered something she thought was fantastic such as a hiding kitty or shampoo bottles in the shower..

A typical home visit includes the phone call to make the appointment. I usually let the applicant know I'll be bringing 'demo dogs' and the visit should last no more than 20-30 minutes. I tell them to relax and don't worry about cleaning up because dogs bring dog hair and muddy paw prints into their homes. Besides, I want to see the family 'as is'! We who live with Labs understand about dog hair, mud, slimed eyeglasses, gooey tennis balls, puddles on the kitchen floor after a good deep drink, and all the antics that keep us on our toes all day every day. Bringing a 'demo dog' to a home visit is a great way to see how much homework a person has done about the breed. It also helps the human evaluator get into the mind of the potential adopter without asking too many questions.

As I mentioned previously, bringing your own dogs to a home visit is very important. In the end, most of my recommendations on the potential family depend on the family's reaction to my dogs being in their home. Kids especially react very naturally to a dog in the house, so I can tell quite a bit on how a family will be with dogs after watching the whole family react to the children with dogs present. For breeders, it's a lot like inviting the family to view the litter they want a puppy from. You get a lot of information by watching how the parents react to the kids reacting to the puppies!

One family I visited said they really wanted a rescued Lab. When I arrived with Rosie and Mango, the 9-year-old daughter spent the whole visit standing on a dining room chair crying. No amount of persuading or bribing or coaxing would get this child off the chair. My dogs snooped and licked and did Labradorable things as they always do. They also stole the sneakers from the wicker basket at the back door, jumped on the sofa where Dad had placed his sheet music, danced over wires hanging from the back of the TV and VCR that was in the middle of the room, and knocked over the trash can in the middle of the kitchen floor. When Rosie decided it was time to complete her job upstairs in the kids' bedrooms, Mom chased Rosie back into the room where she had already investigated everything. Mango tried to get the winter hats left near the shoes and really wanted to hand Dad the TV remote that was left near the sheet music. Mom and Dad assured me that the kids would be fine and that they could handle a dog like Mango. Yes, all 85 pounds of mischief. This reaction, plus the reluctance to provide a fenced area accessible to the door that the kids used to go out to the yard caused me to caution when I wrote my report later. I wasn't so sure they were ready for the activity of a Labrador coming from rescue.

On another home visit to a gent who was about my own age, my dogs were not welcomed into the home very warmly, so I kept them on lead once I realized the man was not happy being checked out by a pair of dogs doing their jobs. When I got into the 'House Beautiful-ly kept home, the gent was very worried about where my dogs were at all times. Unfortunately, Rosie wasn't able to do her job properly. Mango's job is to charm the residents with her sweet nature by flipping on her back and offering her belly to tickle. This particular gent wasn't into belly tickles, and he sure didn't want Rosie looking into his nooks and crannies. He seemed more interested in discipline than Labradorable antics. "NO" was one of his favorite words on our visit...the house was devoid of mess or doggie comforts. It was picture perfect a place to go if you didn't have a dog. The man was polite, and his previous dog had been 'perfect'. There was no fencing around his yard, but the man assured me the neighborhood was dog friendly. I noticed two dogs barking menacingly from next door when I took my girls back to the car at the end of the visit. I took mental notes for my report to be written later. An older man we visited a few months later had just lost his 'perfect' oldie Goldie, and was looking for the next perfect dog. Rosie and Mango were busy doing their home visit jobs, and this gent was a little nervous about what they might be learning about his home. The man spoke lovingly and in glowing terms about his dog and how much a buddy she had been. It was apparent he needed a dog in his life, but in my notes I wondered if the perfect dog was there for him. I wondered if he hadn't had enough time to mourn his loss. His trepidation about Mango and Rosie doing their jobs, and the fact that he lived on a busy corner of two State highways without a fence caused me to caution about placing a dog in the home right away.

One family I visited had a baby girl who was barely walking as well as her older, active, 4-year-old sister. Rosie and Mango burst into the house to the delight of the whole family. We all sat on the floor to play toddler and doggie games. Sofas and beds were within the limits of all the 'kids'.... two and four leggers...the fenced in back yard and photos of the family dogs who had just passed, along with the grand welcome Rosie and Mango received clinched the deal. There were even dog cookies and a water bowl on the floor in anticipation for the visit. This family was ready for a Lab in their lives.

One incredible home visit was to a family who had just moved into a new house in a new town. It hadn't been more than four months since losing their previous rescued Lab, and their hearts ached for a new dog to love. Mom, Dad and the two kids, a boy and a girl, warmly welcomed Rosie and Mango into the home. Boxes were still scattered all over the house from the move, and what to Labs love more than cookies? Boxes containing knows what is what they love! It didn't matter to this family that Rosie and Mango were on the job...not to mention the in ground pool that the kids invited Rosie and Mango into for an afternoon swim...what a treat for Rosie and Mango!

Even with the recent loss of their beloved dog, I knew from the first moment that Rosie and Mango were going to approve this family for a dog. They were a loving family, enjoyed the dogs, had the fence and the pool and the toys...they did get a dog soon after and as far as I know, they are very happy together!

Sometimes Rosie and Mango do too good a job on a home visit. The family is sold on having a dog 'just like Rosie' or 'just like Mango' and they won't even try to consider a dog of a different color, age, or energy level. It's so much better when the family is flexible and will accept a dog maybe a little older or younger, or maybe a black Lab when they really thought they couldn't live without a yellow one. I can't tell you how many times I've heard "Can you just leave Mango here and tell the rescue folks we found what we're looking for?" I just laugh and say thank you...it shows me I've done my job with my own dogs when they make such a good impression on a family we've just met.

Our most recent home visit was to a family with free range chickens. The man wrote on the application form about the chickens, and he told me about them when I made the phone appointment. But what he didn't tell me was that there were 45 chickens that came out of every bush, shrub and tree soon after our arrival. By the time of this visit, I thought I had the most obedience, trained, hunt tested, steady to shot and wing dog in Mango, so she wasn't wearing a collar, and I didn't put a leash on her. After Mango realized how many chickens there were, and how fast they can run, she got drunk on flapping, cackling chickens and no amount of calling her to HEEL HEEL HEEL could get her off her merry chase. To the horror of the family, Mango cornered a chicken under a bush where the two teenage girls and the Dad and I caught Mango before she could think about chucken mcnuggets. I took her firmly by one ear back to the car. There was not ONE bit of remorse on her face. If dogs can smile, Mango's was a grin from ear to ear. Believe it or not, the family sat for the interview and still wanted a Labrador after Mango's display.

Yes, volunteering this way is time consuming, and I have program the GPS to get to places where I have to drive and might still get lost, and yes gas is costly, and think about all the other things I could be doing besides checking out people who think they want a dog...but my heart is always lifted when I get a note telling me that a Lab was placed with a family we've visited. It means Rosie, Mango, and others in the Grampian Pack have helped save another dog from an uncertain existence.

One family I interviewed is local to me, and they are also members of the same yacht club where I've known them for many years. This family was honored to have me visit for an event other than boating, and were all thrilled when only a few weeks later they were able to adopt a yellow girl that they adore. Each time I see the family at the club I get a new 'story' about the dog, and they always thank me for facilitating the adoption. For all the reasons above, I continue to volunteer.

Labrador Retriever Rescue, Inc. is our local Lab Rescue organization. For those of you who are unaware, it serves Maine, Vermont, Rhode Island, New Hampshire and Eastern Massachusetts. AKC Informational Update: Position Statement on Debarking [Friday, August 27, 2010]

At the August Board meeting, the AKC Board of Directors approved an official canine legislation policy position statement on debarking.

Debarking is a viable veterinary procedure that may allow a dog owner to keep a dog that barks excessively in its loving home rather than to be forced to surrender it to a shelter. Debarking should only be performed by a qualified, licensed veterinarian after other behavioral modification efforts to correct excessive barking have failed. As with other veterinary medical decisions, the decision to debark a dog is best left to individual owners and their veterinarians.

Federal PUPS Legislation Information Update [Thursday, July 22, 2010]

The American Kennel Club and our Washington, D.C.-based advocacy team continue to closely monitor S. 3424/H.R. 5434, the federal Puppy Uniform Protection and Safety (PUPS) Act. There has been no official action on the bill since its introduction in late May.

AKC Publications Fiction Contest The American Kennel Club 260 Madison Avenue New York, New York 10016 As previously reported, the 2010 PUPS bill seeks to expand federal regulation of dog breeders who breed and sell more than 50 puppies a year directly to consumers. This version is a significant improvement over previous versions, which focused on the number of dogs owned, regardless of what was bred or sold. This version would require the new category of breeders to abide by basic minimum standards of care and conditions and to abide by new performance-based exercise requirements.

However, the AKC also has a number of serious concerns with the bill as introduced. Some of these concerns include:

•Definition of "breeding female" as an intact female dog aged 4 months or older. Female dogs are not sufficiently mature at 4 months of age to be bred.

•Definition of "high volume retail breeder" that is overly broad and does not take into account co- and joint ownerships. Additionally, a reference in this definition to the number of dogs owned by a breeder is unnecessary and potentially misleading.

•Exercise language should be clarified to ensure that the daily exercise requirements do not preclude training that involves other types of activity as well.

We will continue to monitor this legislation vigilantly and to outline our concerns regarding PUPS legislation to appropriate members of Congress and staff. Given the issues that AKC and other responsible dog owner groups have raised, and that Congress will be in session for fewer than six weeks prior to the November elections, it is not likely that there will be action on PUPS in the near term.

AKC will continue its education campaign with legislators and we will keep you up to date on any new developments.

I had considered making one myself but as I can barely hem my jeans thought I would try you first.

DEAR POOCHIE:

Having always had a houseful of elderly Labradors, both ladies and gentlemen, and never having learned to sew Dear Labby solved this problem to her own satisfaction several years ago. She buys relatively inexpensive men's sweatshirts usually in XL or XXL depending on the size of the dog. She then cuts the sleeves off to make it short-sleeved and tries it on with the front of the neck under the dog's neck. If the dog has a very thick neck you can then cut V shaped pieces out of the neckband until it loosens sufficiently to be comfortable. The next step, particularly in the case of gentlemen Labs, is to gather the waistband up until there is no material sagging underneath to get soiled.
