"New rules, expected to go into effect about March 16, change the mandatory vaccination period from two to three years. **WCI:** Double on land and double on water, 75 – 100 yard retrieves, moderate cover, decoys, **NO BLIND**, on-lead honor; not gun shy, steady off lead, delivery to hand, boat may be used, proper hunting attire or dark clothing required.

**WCX:** Triple on land and triple on water or land/water, 75-100 yards retrieves, 50-75 yard blind(s) on land and/or water (outside the marks), diversion shot, duck calls, decoys, off-lead honor; not gun shy, steady off lead, delivery to hand, boat may be used, proper hunting attire or dark clothing required.

GAME: Ducks in WC, ducks/chukars in WCI/WCX.

Out of courtesy to our judges, please be sure that your dog is prepared for situations he will encounter in the test, such as gunshots, live birds, bird boys, long swims, boats and moderate cover.

#### DEAR LABBY:

I have been using my blender to make weaning food for my puppies. I never seem to be able to get it completely clean and end up eating puppy food myself in one form or another. Is there another way to do this?

#### TIRED OF PUPPY SMOOTHIES

#### **DEAR PUPPY SMOOTHIE:**

Dear Labby can empathize with your predicament having done it herself in the past. We now put our puppies' food in shallow stainless pans, add very hot water and place a cover over the pan which will fit tightly. A dinner plate works for our pans. Let the water completely absorb and be sure the food is not too hot when served. It may take a couple of tries to be able to judge exactly the correct amount of water. We then take a potato masher (to get out the lumps if any are left) or a whisk and mix it thoroughly. We have found it might take a bit longer than the blender method but if you factor in the cleaning time necessary for the blender it really is quicker and the food seems to have more texture.


